UTILIZATION MANAGEMENT

Blue Cross and BCN Pharmacy departments — CAR-T cell therapy

Makes prior authorization determinations for appropriateness of care for CAR-T cell therapy.

Submit authorization requests through the NovoLogix® online tool.

Note: AIM Specialty Health® makes authorization determinations for other medical oncology and supportive care drugs.

The pharmacy department provides these services for the following groups and individual members:

- Blue Cross commercial — All fully insured groups, all self-funded groups* and all members with individual coverage
- Medicare Plus BlueSM — All groups and all members with individual coverage
- BCN commercial — All fully insured groups, all self-funded groups* and all members with individual coverage
- BCN AdvantageSM — All groups and all members with individual coverage

UTILIZATION MANAGEMENT

AIM Specialty Health® — medical oncology

Makes authorization determinations for appropriateness of care for medical oncology and supportive care drugs that are covered under the medical benefit.

Submit prior authorization requests through the AIM *ProviderPortal*.

Note: The Blue Cross and BCN Pharmacy departments make authorization determinations for CAR-T cell therapy drugs.

AIM provides these services for:

- Blue Cross commercial
 - All fully insured groups
 - Select self-funded groups* — To determine which self-funded groups participate in this program, see the [AIM medical drug prior authorization opt-in list](#).
 - All members with individual coverage
- Medicare Plus BlueSM — All groups and all members with individual coverage
- BCN commercial — All fully insured groups, all self-funded groups* and all members with individual coverage
- BCN AdvantageSM — All groups and all members with individual coverage

UTILIZATION MANAGEMENT

AIM — radiation oncology

Makes prior authorization determinations for radiation oncology, including proton beam therapy.

Submit authorization requests through the AIM *ProviderPortal*.

AIM provides these services to Blue Cross commercial members as follows:

- **For proton beam therapy**, AIM makes prior authorization determinations for the following Blue Cross commercial groups:
 - Select fully insured groups — For Michigan Education Special Services Association, or MESSA, only
 - Most self-funded groups* — **Exceptions:** Select Ascension Health groups, Blue Cross and Blue Shield Federal Employee Program® and State of Michigan plans
- **For radiation oncology other than proton beam therapy**, AIM makes prior authorization determinations for the following self-funded group members*: UAW Retiree Medical Benefits Trust non-Medicare.

Exceptions: UAW Retiree Healthcare Trust (group 70605) and UAW International Union (group 71714)

UTILIZATION MANAGEMENT

eviCore healthcare — radiation oncology

Makes authorization determinations for radiation oncology, including proton beam therapy.

Submit authorization requests through the eviCore portal.

eviCore provides these services for the following groups and individual members:

- Blue Cross commercial
 - Most fully insured groups — **Exception:** Michigan Education Special Services Association, or MESSA
 - All members with individual coverage
- Medicare Plus Blue — All groups and all members with individual coverage
- BCN commercial — All fully insured groups, all self-funded groups* and all members with individual coverage
- BCN Advantage — All groups and all members with individual coverage
